The Programme

During this program, we will stay with host families, hostels, and in a holiday parks, visit several schools and universities, discuss Sustainable Goals with other students, visit Dutch cultural places, castles and caves, nature day, and many other interesting projects.

Part of the experience would be visiting various historical and current government entities within the Netherlands and will include a trip to Belgium, Germany, and Paris.

To learn together: The 17 Sustainable Development Goals (SDGs) set out by the United Nations as illustrated in the above picture, form the theoretical underpinning of the program.

The knowledge that students gain during their preparation period can be put into practice by the numerous activities that will be prepared in cooperation with the local students in the host country concerning these goals.

To live together: All participating students stay with Dutch host families or sleep at schools and other alternative accommodations as arranged by the Host.

This way, the students can learn about their daily lives, how to communicate, food and drinks, and how to work in the host country.

To be together: By closely living together for two weeks, the realization of interdependence with others will grow. What happens there – so far away - also influences life in South Africa.

Legal obligations for the minor child, under 18 years of age.

1. Protection Of Personal Information Act, no. 4 of 2013 (POPIA)

Please note that information is confidential and will only be shared with our partners in the Netherlands, and as the parent/guardian, we need your consent to process personal information in terms of the Protection of Personal Information Act, no. 4 of 2013 (POPIA). This will be issued once the child has signed up.

2. Completed Visa Application Forms will be supplied.

(Please note, this is non-negotiable as we must book and submit applications as soon as possible to secure an appointment with the Embassy)

To be able to start the process, the following documents are urgently required:

- a. **valid passport** this can be done at your bank or at Home Affairs both parents to accompany the minor child.
- b. **certified copy of an unabridged birth certificate**/equivalent document not older than 3 months (2 copies)
- c. **parental consent form 1** will be issued upon sign-up Visa consent for the Dutch Embassy, to take your child out of the country. to be signed at the police station by both parents.
- d. **proof of address**: for visa application
- e. **parents' 3-month bank statement:** for visa application (this the parent will bring when accompanying the child to the embassy)
- f. **parental consent form 2** Department of Home Affairs to grant permission to take your child out of the country (presented at the airport when going through customs) to be signed at the police station by both parents and the chaperone. Only needed in January 2025 before departure
- g. **parental consent 3**: affidavit from the police station Only needed in January 2025 before departure
- h. contact details of the parent(s)/legal guardian(s)
- i. where applicable (certified copies)
 - o copy of a death certificate if one of the parents are deceased
 - copy of an adoption order
 - o copy of a court order granting full parental responsibilities and rights / legal guardianship in respect of the child.
- j. All forms are to be completed and signed by both parents and/or the legal custodian/guardian.

- k. Certified copies not older than 3 months, of parents' Smart ID (original to be presented at Visa appointment) <u>Parents will have to accompany a minor to the Dutch Embassy</u>. (We will submit online applications and make group appointments)
- I. **Travel insurance** will be purchased for the group.
- 3. Estimated Cost per person: R61 000 and includes the following:
 - Schengen Visa
 - Airfare
 - Transfers
 - Accommodation
 - All Meals

- Travel Insurance
- Excursions at the Louvre and Eiffel Tower
- T-Shirt

(Please note, this does not include pocket money for your child)

The following deadlines apply:

- ❖ <u>Deposit R15 000: Non-refundable</u> to be paid by: 30 August 2024.
- ❖ Monthly payments R15000: Last day of each Month.
- Final payment by 30 March 2025.

We are working on sourcing sponsorship as far as possible but cannot guarantee it. Please let us know if you can assist us with sourcing sponsorships.

(Will only be issued once the deposit is paid. This is to safeguard us as well as Roosevelt High)

Should you wish to source sponsorship for your child, we are willing to provide the sponsor with supporting documents as well as write a proposal to the potential sponsor on your behalf.
